HAVE YOU BEEN TESTED FOR SICKLE CELL?

Sickle Cell Disease (SCD) is a hereditary genetic blood disease caused by an abnormal form of hemoglobin, the molecule in red blood cells that helps carry oxygen. It can cause a lot of health issues, resulting in pain crises, and even organ damage. In Ontario, around 150,000 people carry the Sickle Cell Trait (SCT), most of whom are unaware they carry the gene until they have a child born with SCD.

Although the SCT is asymptomatic, meaning it usually doesn't cause symptoms, it's important to know your status to manage your health better and make informed family planning choices. For example, if both parents have the SCT, their child has a 25% chance of inheriting SCD. Additionally, knowing your SCT status can help you and your doctor take steps to prevent potential health issues related to overexertion and dehydration, particularly if you're an athlete. You can find out if you have SCT with a simple blood test called hemoglobin electrophoresis, available for free through your family doctor in Canada.


